Program Description

This Continuing Education Program is presented by The Wilkes-Barre Law and Library Association, the Luzerne County Medical Society, and Wilkes University. The CLE portion is sponsored by the Association's Medical-Legal/Disabilities Committee, Chaired by Jaqueline A. Zabresky, JD, RN. And, the MCE portion is being sponsored with the Luzerne Medical Society Foundation. It is a joint Continuing Legal Education course for lawyers and a Continuing Medical Education course for doctors. **The event will also be open to Wilkes students, other medical professionals and members of the public.**

The program will feature a panel consisting of the following presenters: Attorney Paul Brazil from MyVaccineLawyer.com; Pediatrician, Dr. Timothy Welby, and Pharmacist Nicole Pezzino. The program will be moderated by Mark Hiller of WBRE TV. It may be videotaped for broadcasting on that station.

The course is designed to provide information for the, lawyer, doctor and lay person on the legal and medical issues surrounding immunizations and vaccinations. For lawyers, topics covered will be the Special Vaccine Court; the Vaccine Injury Claims Process; Types of Compensation; Vaccines Covered; Vaccine Injuries, and Vaccine Injury Case Results. Those attorneys staying for the full duration of the program, this CLE program offers and is approved by the CLE Board for two (2) hours of substantive continuing legal education credit.
