**Annual Meeting Minutes**  
**Thursday—January 20, 2022**

The Annual Meeting was held on Thursday, January 20, 2022 at noon in Courtroom #1 of the Luzerne County Courthouse and streamed via Polycom on Zoom by Gail Kopiak, Deputy Executive Director, to the members. Catherine R. O'Donnell, President, presided at the start of the meeting, which began with the Pledge of Allegiance led by Cheryl Sobeski-Reedy.

A motion was made and seconded to approve the Meeting's Agenda and the Minutes of the 2021 October Quarterly Meeting as published. This was followed by a Report and Update on 2022 Bar Dues by Treasurer, Joseph P.J. Burke, III.

Comments were then delivered by President O'Donnell, who then called upon Michael I. Butera, Chairperson of the Nominating Committee (appearing on Zoom) for a report and call for a vote upon the nominations of the 2022/23 Officers and Executive Committee.

The oath was given by President Judge Emeritus Correale F. Stevens of the Pennsylvania Superior Court, who was in the Court Room, with President Judge Vough and Judge Gelb of

the Court of Common Pleas. Following being sworn in, President Mecadon assumed the podium and delivered remarks. President Mecadon then called upon the Honorable Michael T. 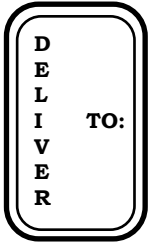
