#### **BIOGRAPHY JOSEPH J. MUSTO**

The Honorable Joseph J. Musto is a graduate of King's College and the Dickinson School of Law. He is admitted to the Pennsylvania Supreme, Superior and Commonwealth Courts, the Third Circuit Court of Appeals, and the United States District Courts for the Middle and Eastern Districts of Pennsylvania. He has tried cases to jury verdict in both civil and criminal cases in the courts of Lackawanna, Lehigh, Luzerne, Monroe, Schuylkill and Wyoming Counties and the Federal District Court for the Middle District of Pennsylvania.

Judge Musto served as an Assistant District Attorney in Philadelphia, and also was a partner or principal in the law firms of Bedford, Waller, Griffith Darling & Mitchell, Griffith, Aponick & Musto, Rosenn Jenkins & Greenwald and Hourigan, Kluger & Quinn.

He served as a trial judge in the Luzerne County Court of Common Pleas, and as a Hearing Officer and Administrative Law Judge under the Federal and Pennsylvania Medicare and Medicaid Programs. Judge Musto has served as Solicitor to the Pittston Area School District, Duryea and Yatesville Boroughs and as an Assistant Luzerne County Solicitor. He has been a Mediator and Neutral Arbitrator for the past 25 years.

Judge Musto is a member of the Pennsylvania Bar Association and Wilkes-Barre Law and Library Association. He is a past President of the Federal Bar Association, Central Pennsylvania Chapter. He also was co-chair of the Pennsylvania Bar Association Committee which reviewed and made comment on the recently adopted Evidence Code. He was also a member of the Civil Justice Reform Act Advisory Committee of the Federal Court for the Middle District of Pennsylvania. He is a past Member Advocate of the American Board of Trial Advocates.

He currently serves as law clerk to the Honorable Tarah Toohil, Judge of the Court of Common Pleas of Luzerne County.

Judge Musto is married to Attorney Fortunata Musto. They have two children, Laura Kapalka and Rob Musto, and three grandchildren, Olivia and Joey Musto and Richard Joseph (RJ) Kapalka.
