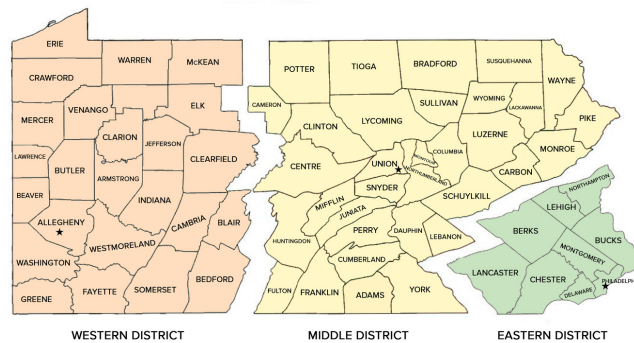

The Pennsylvania Institutional Law Project (PILP) seeks to advance the civil and constitutional rights of people incarcerated or detained in Pennsylvania.

We are a legal aid organization that provides free civil legal assistance to people who are incarcerated or detained in Pennsylvania who have civil or constitutional rights issues related to their conditions of confinement.
