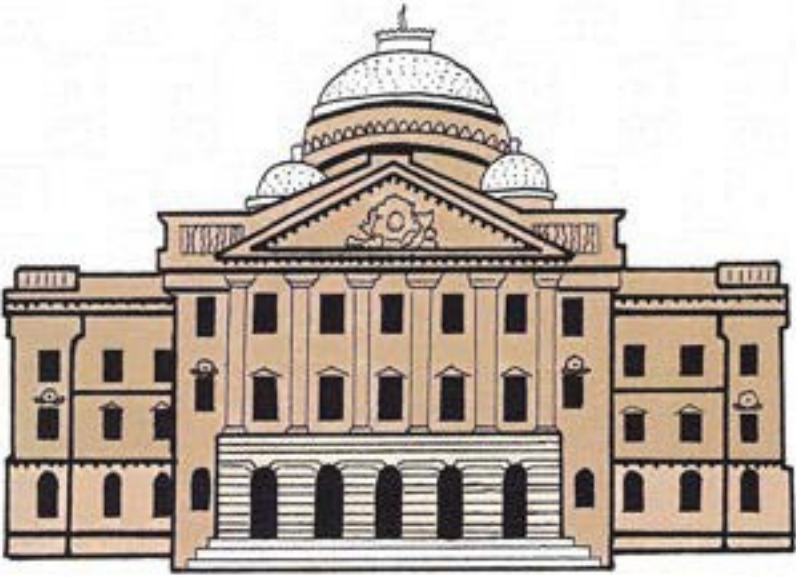

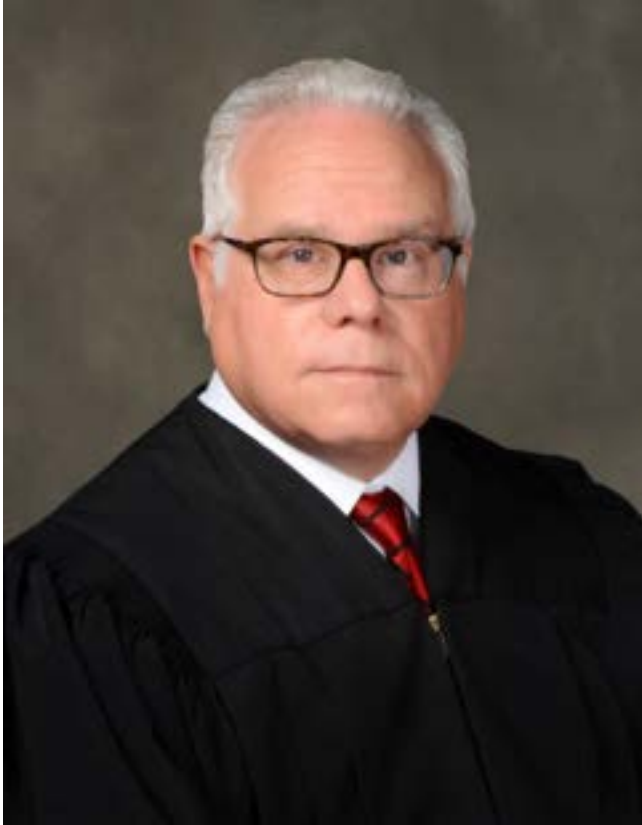

Governor-Elect Matthew S. Meyer

Matt Meyer, the grandson of Bar President Louis Shaffer, Esq., who served as president from 1961-1963, was elected last week to be Governor of Delaware. Matt is also the nephew of Attorney Jerry Chariton, who is the chair of our Orphans' Court Committee. Matt is also related to Bar President Charles A. Shaffer, Esq, who served as president from 1998-1999.

It was under Louis Shaffer that our Law Library and Lawyer's Lounge (now the Presidents' Room) was originally renovated back in 1962. The work was reported as being complete at the Annual Meeting of January 21, 1963. When Charles became president 37 years later, Charles led the effort to re-renoate the Law Library, which by then needed attention again. At that time, the Association checked into the possibility of re-electrifying the 1909 side lights and the majestic antique chandelier that commands the Mian Room of the Law Library; however, the technology did not exist to re-connect the lights. In the quarter century since 1998, great strides have been made in lighting technology. These advances allowed us to achieve our objective this year. The relighting of the 1909 chandelier and side lights went off without a hitch. A bonus from the modern lights is the bulbs emit more light than the old bulbs. We were also successful in retro fitting the recessed lights in the ceiling. Together the recessed lights and 1909 lights produce enough light in the room that we were able to disassemble and remove the old 1960s track-lighting. You can now see more of the ornate ceiling and view it without distraction, and the lighting now in the room, bathes the Main Room in a soft, warm light.

The overall effect is to create a very inviting mood in the Main Room.

With the Association poised to celebrate its *175th Anniversary* next year, restoring the Main Room to its majesty seems very appropriate.

The vote to do this was made at the April Quarterly Meeting upon the motion of Atty. Charles Shaffer and seconded by, long-term member, Atty. Don McFadden. When you see them, be sure to thank Charles and Don. Also, congratulate Charles and Jerry on Matt's election. And do make sure to come to the Courthouse and see the Law Library in person. We think you will like it!
