AND NOW, this 24th day of January, 2025, it is OR-DERED that effective **March 3, 2025**, a filing for Petition for Modification of a Custody Order and Petition to Intervene in a Custody Action shall be assessed a **\$27.00** filing fee collected by the Luzerne County Office of Judicial Records.

The moving party presenting the Petition for Modification of a Custody Order and a Petition to Intervene in a Custody Action shall be responsible for the \$27.00 filing fee.

If the moving party is indigent and has an IFP approved by a judge on the docket, it shall be honored by the Office of Judicial Records for a period of one (1) year. After that year, the moving party will be required to reapply for any subsequent year. If financial circumstances change within the approved timeframe, the moving party is required by law to notify the Court of the improvement in financial circumstances. Pa.R.C.P. 240(e).


